 I AGREE that I choose to participate voluntarily in the Competition with my horse, as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, trainer, or as parent or guardian of a junior exhibitor. I am fully aware of and acknowledge that horse sports and the Competition involve inherent dangerous risks of accident, loss, and serious bodily injury, including broken bones, head injuries, trauma, pain, suffering, or death ("Harm")
 I AGREE to release SEC, the Competition, the CHJA, NEHC, CHSA and M&S League from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm caused by me or my horse to others, even if the Harm resulted, directly or indirectly, from the negligence of the of the Competition.
 I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) SEC and the Competition and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for and Harm caused by me or my horse at the Competition. I have read the rules about protective equipment, and I understand that I am entitled to wear protective equipment without penalty, and I acknowledge that SEC strongly encourages me to do so while WARNING that no protective equipment can guard against all injuries.
